BATHURST, New Brunswick – (Friday, August 14th, 2020) Fiddlehead Mining Corp. ("FMC" or the "Company") is pleased to announce that it has greatly enhanced the surface expression of the Willett VMS Lens @ our Stonehenge Showing on the Nine Mile South property. This is a very important discovery for the VMS Exploration Model. Lens' usually occur in multiple "stacked" systems. The newly increased exposed Lens at surface measures 10m in length x 2m in width before it dips below surface. We are excited to find the additional Lens' and define the complete Lens here at Fiddlehead's Nine Mile South Project.

Fiddlehead has sampled the exposed sulphide Lens & submitted the rocks for Assay including (Lead, Zinc, Copper, Gold & Silver). We have decided to accelerated our exploration program @ Nine Mile South and applied for Permits from NB Energy and Mines and Forestry to clear the area to fully expose the occurrence and surrounding host rocks.. We have initiating a Drone Analysis of the immediate area and have commenced a large, close spaced soil sampling program along strike to both the northeast and southwest to assist in locating potential extensions or additional blocks of similar mineralization.

Fiddlehead with be applying for Drill Permits through the Department of Energy and Mines. And expects to Drill this area this Fall.

The New Brunswick Department of Mines and Energy website describes past assays records returning up to Lead (Pb) 12.83% Pb Zinc (Zn) 9.78% (Combined 22.61%) & Copper (Cu) 3.17%, Silver (Ag) 473.89 g/t (14.81 oz/t) and 4.1 g/t Gold (Au).
